Ms. Zakia Sultana has been serving as Secretary, Ministry of Industries from 16th May 2021 and she has been promoted to Senior Secretary to the Government of the People's Republic of Bangladesh on 27 September 2023. Ms. Zakia Sultana is an officer of BCS (Administration) of the 10th batch. Prior to her present position, she worked as Chairman of Bangladesh Energy and Power Research Council as a Secretary of the Government of the People's Republic of Bangladesh since 10th January 2021. Before that she worked as an Additional Secretary of the Financial Institutions Division under Ministry of Finance.
