Dear Sir,

Please be informed that Bangladesh Small and Cottage industries Corporation (BSCIC) under Ministry of Industries has been working for the implementation of sustainable Universal Salt Iodization (USI) in Bangladesh to eliminate Iodine Deficiency Disorder from the country. BSCIC regularly procures Potassium Iodate (KIO<sub>3</sub>) and supply it to the salt mills for salt fortification. Currently, the procurement of 20 MT Potassium Iodate (KIO<sub>3</sub>) is being processed. SO, BSCIC needs a reliable C&F agent who will clear & forward the imported Potassium Iodate (KIO<sub>3</sub>) and deliver it to BSCIC warehouses.

## Description of the product (as it is going to be imported):

## Responsibilities of C&F Agent:

The C&F agent is expected to perform clearing, forwarding, delivering (transport) activities. The responsibilities will be as follows:

- To release 20 MT Potassium Iodate (KIO<sub>3</sub>) from Benapole Land Port safely. No damage shall be made by C&F Agent. If any, the C&F Agent shall pay for the loss.
- To deliver imported Potassium Iodate (KIO<sub>3</sub>) to BSCIC warehouses located in 8 Salt Zones (Dhaka, Narayangonj, Chandpur, Chittagong, Patiya, Cox's Bazar, Khulna & Jhalokathi) of BSCIC.
- Essential documents must be submitted and maintained properly. The C&F Agent will be
  required to undertake all works in connection with Benapole Land Customs for clearance and
  dispatch of imports according to the instruction of the authorized officers of BSCIC, Dhaka
  as and when called upon to do so. They will also undertake the forwarding when required.



#### **Terms of Payment:**

- The C&F agent will submit their bill with original invoices after the successful port release & delivery of imported 20 MT Potassium Iodate (KIO<sub>3</sub>) to BSCIC warehouses located in 8 Salt Zones of BSCIC.
- The payment will be made upon:
  - C&F Commission
  - Loading-unloading Charge
  - Transportation Cost
  - Miscellaneous & Contingency
- In case of discrepancy between words and figures, the former will govern. In case of quotation submitted on lump-sum basis, if anomalies found between figures and words, the words will prevail. Quotation submitter shall remain bound to accept the arithmetic corrections made by the Evaluation Committee.
